Johnson	Columbus	Private	Wounded at Battle of Murfreesboro on Dec. 31, 1862; in January 1863 he was detailed to work on the Nashville & Chattanooga Railroad until at least May 1863; Confederates list he deserted Nov. 10, 1863 but Federals state he was captured on Nov. 13, 1863 at Will's Valley (near Lookout Mountain); he was sent to Rock Island Prison Camp; in Dec. 1863 Columbus' father sent a letter to Gen.
